

FACTS	WHAT DOES UNION STATE BANK DO WITH YOUR PERSONAL INFORMATION?
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li style="display: inline-block; width: 45%;">• Social Security Number and income</li> <li style="display: inline-block; width: 45%;">• Assets and investment experience</li> <li style="display: inline-block; width: 45%;">• Account balances and payment history</li> <li style="display: inline-block; width: 45%;">• Account transactions and checking account information</li> <li style="display: inline-block; width: 45%;">• Credit history and credit scores</li> <li style="display: inline-block; width: 45%;">• Credit card or other debt</li> <li style="display: inline-block; width: 45%;">• Transaction or loss history</li> <li style="display: inline-block; width: 45%;">• Insurance policies and appraisals</li> </ul>
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Union State Bank chooses to share; and whether you can limit this sharing.

What we do	
How does Union State Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Union State Bank collect my personal information	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>• open an account or deposit money</li> <li>• pay your bills or apply for a loan</li> <li>• use your credit or debit card</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>• sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>• affiliates from using your information to market to you</li> <li>• sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choice will apply to everyone on your account – unless you tell us otherwise.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>• Our affiliate that we share information with is the Novak Agency, Inc.</li> </ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>• Union State Bank does not share information with nonaffiliates so they can market to you.</li> </ul>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners are: <ul style="list-style-type: none"> <li>• Élan Financial Services to provide credit cards to consumers and businesses.</li> <li>• Elite Payment Systems to provide merchants the ability to accept credit cards at their business.</li> <li>• IStream Financial Services to provide remote deposit services for businesses.</li> </ul>
